Climate Change, Air and Water Quality, and Biodiversity: a) Protected water quality by successfully passing Senate Bill 346 - powerful legislation that phases out copper from vehicle brake pads to make the State's urban waterways safer for salmon and other aquatic species. The legislation, and the process of developing it through Sustainable Conservation's Brake Pad Partnership, shows that when business, environmental and governmental stakeholders work together, our State legislature can approve meaningful legislation that protect the environment and support a healthy economy. b) Reduced air pollution by expanding innovative farming practices in California's Central Valley. Through conservation tillage, a less polluting and less costly method of cultivating crops, Sustainable Conservation's farming partners have cut dust and diesel emissions, by 70% and 45% respectively, since 2003. Conservation tillage also improves soil drainage, organic matter and moisture content which helps sequester carbon, improve water quality and create habitat. Between 2008-2010 Central Valley farmers adopted conservation tillage practices on nearly one million acres of row crops, including wheat silage. That's more than 1,500 square miles that represents nearly 15% of all row-crop acreage in California. c) Protected biodiversity by leading PlantRight, a coalition of California nurseries, retailers and other horticulture partners to prevent the sale of invasive plants. PlantRight has the potential to reduce the more than \$80 million California spends each year to control and eradicate invasive species - the second greatest threat to biodiversity behind habitat destruction. In 2011, our second annual statewide nursery survey indicated that 15 of PlantRight's 19 target species were no longer available on retail shelves, a great indicator of campaign progress.
