IN 2014, WE CONTINUED HELPING FARMERS SWITCH TO LOW-INTENSITY CULTIVATION PRACTICES THAT REDUCE DUST AND DIESEL EMISSIONS FROM TRACTORS-SO COMMUNITIES BREATHE EASIER-WHILE SAVING TIME AND MONEY ON FUEL, LABOR, AND MAINTENANCE. SUSTAINABLE CONSERVATION MAKES IT EASIER FOR LANDOWNERS TO STEWARD NATURAL RESOURCES. WE WORK WITH THE LEGISLATURE AND GOVERNMENT AGENCIES TO SIMPLIFY THE PERMITTING PROCESS SO LANDOWNERS CAN COMPLETE PROJECTS THAT RESTORE STREAMS, REBUILD HABITAT, AND REDUCE SOIL EROSION IN A FEW MONTHS RATHER THAN A FEW YEARS. PLANTRIGHT PARTNERS WITH PLANT GROWERS AND RETAILERS, PROFESSIONAL GARDENERS, AND OTHERS TO STOP THE SALE OF INVASIVE PLANTS AND PROMOTE BETTER OPTIONS. OUR 2014 ANNUAL SURVEY INDICATED THAT THE PERCENTAGE OF NURSERIES CARRYING AN INVASIVE PLANT ON PLANTRIGHT'S ORIGINAL LIST (COHORT 1) DECREASED FROM AROUND 30% OVER THE PAST THREE YEARS TO 18% IN 2014. IN 2014, WE FORMALLY SIGNED THE HOME DEPOT TO PLANTRIGHT'S RETAIL PARTNERSHIP PROGRAM. GIVEN THAT BIG BOX STORES REPRESENT 70% OF RETAIL PLANT SALES IN CA, THIS WILL HELP US FURTHER REDUCE THE NUMBER OF STORES THAT CARRY INVASIVE PLANTS.
