SUSTAINABLE CONSERVATION EVALUATES NEW WATER MANAGEMENT APPROACHES SO FARMS, THE ENVIRONMENT, AND COMMUNITIES HAVE THE WATER THEY NEED FOR YEARS TO COME. WE WORK IN THE CENTRAL VALLEY TO PROMOTE THE CAPTURE OF STORM WATER FLOOD FLOWS ON ACTIVE FARMLAND TO REPLENISH GROUNDWATER AQUIFERS, CALIFORNIA'S MOST IMPORTANT DROUGHT RESERVE. IN 2017, SUSTAINABLE CONSERVATION ACTIVATED GROUNDWATER RECHARGE ON OVER 250 FARM FIELDS IN PARTNERSHIP WITH INDIVIDUAL FARMERS AND 2 IRRIGATION DISTRICTS. THESE DEMONSTRATION FIELDS RECHARGED OVER 7,000 ACRE- FEET OF WATER, THE EQUIVALENT OF SUPPLYING UP TO 14,000 HOUSEHOLDS FOR 12 MONTHS. WE ALSO COMPLETED OUR PROTOTYPE GROUNDWATER RECHARGE ASSESSMENT TOOL WITH GUIDANCE FROM THE TULARE AND MADERA IRRIGATION DISTRICTS.

DAIRIES: WE WORK WITH CALIFORNIA DAIRY PRODUCERS TO PROMOTE MANAGEMENT PRACTICES THAT ARE MORE PROTECTIVE OF WATER AND AIR QUALITY AND WORK ECONOMICALLY. TWO YEARS AGO, WE TESTED AND REFINED AN INNOVATIVE LIQUID MANURE DRIP IRRIGATION SYSTEM THAT APPLIES NUTRIENTS MORE PRECISELY TO CROP ROOT ZONES, WHICH IN TURN LEADS TO SIGNIFICANTLY LESS NITROGEN LEACHING INTO GROUNDWATER SUPPLIES. THE SYSTEM REDUCED NITRATE LEACHING BY 52%, AND INCREASED CROP YIELD BY 15%. A NATIONAL CONSERVATION INNOVATION GRANT ENABLED US TO EXPAND TO THREE ADDITIONAL, GEOGRAPHICALLY DIVERSE DAIRIES COVERING MORE THAN 200 ACRES IN THE SAN JOAQUIN VALLEY. WE INSTALLED SYSTEMS AND BEGAN MONITORING CORN AND WHEAT GROWN WITH MANURE-BASED FERTILIZER DELIVERED VIA SUBTERRANEAN TUBING.

WE WORK WITH THE LEGISLATURE AND GOVERNMENT AGENCIES TO SIMPLIFY THE PERMITTING PROCESS SO LANDOWNERS CAN COMPLETE PROJECTS THAT RESTORE STREAMS, REBUILD HABITAT, AND REDUCE SOIL EROSION IN A FEW MONTHS RATHER THAN A FEW YEARS. IN 2017, WE SECURED COMMITMENTS FROM THE ARMY CORPS OF ENGINEERS, US FISH AND WILDLIFE SERVICE AND CALIFORNIA STATE WATER RESOURCES CONTROL BOARD TO DEVELOP A STATEWIDE SIMPLIFIED PERMITTING PROGRAM WITH THEIR AGENCIES. WE ALSO TRAINED CA DEPT. OF FISH AND WILDLIFE (DFW) STAFF TO BETTER UTILIZE THE STATEWIDE PERMIT WE HELPED THEM ESTABLISH. THERE ARE NOW 27 PROJECTS IN 18 COUNTIES AROUND THE STATE THAT BENEFITED FROM THE DFW PERMIT AND MORE COMING EVERY MONTH.
